Eligibility criteria *

In order to qualify for a FREE place on this course, you must be eligible for us to claim funding to cover the costs. The eligibility criteria are as follows:

- Aged 19 or older on 31 August 2023
- You are a citizen of a country within the European Economic Area (EEA) or other countries
 determined within the EEA, including those with bilateral agreements such as Switzerland, or have
 settled status or the Right of Abode in the UK (including Afghanistan, Hong Kong and Ukraine)

have been ordinarily resident in the EEA or other countries determined within the EEA, including those with bilateral agreements such as Switzerland, for at least the previous 3 years on the first day of learning (does not apply to Afghanistan, Hong Kong and Ukraine)

- you must attend regularly, more than 50% of the classes
- you must fully complete an enrolment form
- You must complete an individual learning plan (ILP) on a regular basis

If you do not qualify for a free course, then you can attend by paying the relevant fee.
