<b>Course Title</b>	Beginners' English – Mixed Level 1&2			
<b>Course Description</b>	<p>This 10-week course is for non-native speakers who are aiming to improve their level of English (A2-B1+) and are looking for a mixed level group where they can practice day to day conversations in English. The course will be tailored towards students' needs to a certain extent but will also cover basic functional language required in everyday life.</p> <p>Although there will be a large element of mainly speaking and listening, lessons will also incorporate work on grammar, vocabulary and pronunciation.</p>

<b>Skills or qualifications needed for entry into the class</b>	Basic knowledge of the English language, both spoken and written. No entry qualifications are required to attend this course.

<p>To increase students' confidence when using English to communicate.</p> <p>To improve students' abilities to use grammar and vocabulary correctly.</p> <p>To introduce language which will be useful for everyday life through topics such as shopping, telling the time and giving directions, work, money and transport.</p> <p>Students will also learn about British culture as well as having the opportunity to learn and talk about each other's native countries.</p>

<b>How progress &amp; success will be recorded</b>	
Students will have a record of progress through written tasks completed throughout the course and discussions with the tutor. You will also be required to write a weekly diary, known as an individual learning plan as you progress through this course.

### **Eligibility criteria \***

In order to qualify for a FREE place on this course, you must be eligible for us to claim funding to cover the costs. The eligibility criteria are as follows:

- Aged 19 or older on 31 August 2024
- You are a citizen of a country within the European Economic Area (EEA) or other countries determined within the EEA, including those with bilateral agreements such as Switzerland, or have settled status or the Right of Abode in the UK (including Afghanistan, Hong Kong and Ukraine) **AND** have been ordinarily resident in the EEA or other countries determined within the EEA, including those with bilateral agreements such as Switzerland, for at least the previous 3 years on the first day of learning (does not apply to Afghanistan, Hong Kong and Ukraine)
- you must attend regularly, more than 50% of the classes
- you must fully complete an enrolment form
- You must complete an individual learning plan (ILP) on a regular basis

If you do not qualify for a free course, then you can attend by paying the relevant fee. We can arrange a payment schedule of instalments for this course.

## Enrolment and Payment
