Course Description	This 10-week course is for non-native speakers who are aiming to improve their level of English (A2-B1+) and are looking for a mixed level group where they can practice day to day conversations in English. The course will be tailored towards students' needs to a certain extent but will also cover basic functional language, required in everyday life.  Although there will be a large element of mainly speaking and listening, lessons will also incorporate work on grammar, vocabulary and pronunciation.  This course is designed to improve English skills, preparing learners with potential job prospects and to increase confidence in communication.

# Course aims & objectives

To increase students' confidence when using English to communicate.

To improve students' abilities to use grammar and vocabulary correctly, preparing learners for further education or employment opportunities.

To introduce language which will be useful for everyday life through topics such as shopping, telling the time and giving directions, work, money and transport.

Students will also learn about British culture as well as having the opportunity to learn and talk about each other's native countries.

#### FUNDING Eligibility criteria \*

To qualify for a FREE place on this course, you must be eligible for us to claim funding to cover the costs. The eligibility criteria are as follows:

- Aged 19 or older on 31 August 2025
- You are a citizen of a country within the European Economic Area (EEA) or other countries determined within the EEA, including those with bilateral agreements such as Switzerland, or have settled status or the Right of Abode in the UK
- You have been ordinarily resident in the EEA or other countries determined within the EEA, including those with bilateral agreements such as Switzerland, for at least the previous 3 years on the first day of learning (currently does not apply to Afghanistan, Hong Kong and Ukraine)
- Funding may also be available for you to attend this course, if you are currently living in the local area and hold a British Nationals (BNO) visa as part of the BN(O) UK Welcome Programme
- You must complete an assessment session and enrolment paperwork to join the course.

If you do not qualify for a free course, then you are welcome to attend the course by paying the relevant fee. We can arrange for a payment schedule of instalments for this course, please contact us for further details.

## **Enrolment and Payment**

#### **Enrolment and payment**

Enrolments in person, for all our courses, can take place from our office based at Comberton Village College. Please note, the quickest way to enrol onto a class will be to visit our website and follow the online booking links from there. Online enrolments can be paid directly in GBP (Sterling) via a secure server over the internet by debit or credit card. Online enrolment will ask for additional information that will enable us to register you, on your chosen course and allocate your payment accordingly.
