We will all join in on analysing a typical case (based on a real-life scenario). This unfolds from initial statements received to the mounting of a full-scale paranormal investigation. Our course will cover a wide range of related topics, from ghosts and poltergeists to working with psychic mediums and much, much more.</p>
